On May 8, 2018, the board of directors of the general partner of Sanchez Midstream Partners LP (the "Partnership") declared a first quarter 2018 cash distribution on its common units of \$0.4508 per unit (\$1.8032 per unit annualized) payable on May 31, 2018 to holders of record on May 22, 2018. The Partnership also declared a first quarter 2018 distribution on the Class B preferred units and elected to pay the distribution in cash. Accordingly, the Partnership declared a cash distribution of \$0.28225 per Class B preferred unit payable on May 31, 2018 to holders of record on May 22, 2018.
