As calculated in accordance with Rule 13d-3 of the Securities Exchange Act of 1934, as amended, (i) Sabby Healthcare Master Fund, Ltd. and Sabby Volatility Warrant Master Fund, Ltd. beneficially own 500,000 and 200,000 shares of the Issuer's common stock (common shares), respectively, representing approximately 5.04% and 2.02% of the Common Stock, respectively, and (ii) Sabby Management, LLC and Hal Mintz each beneficially own 700,000 shares of the common shares, representing approximately 7.05% of the common shares.
