This Amendment No. 5 to Schedule 13G relates to the Common Stock, par value of \$0.0001 per share (the "Common Stock") of ViaSat, Inc., a Delaware corporation (the "Issuer"), which has its principal executive office at 6155 El Camino Real, Carlsbad, CA 92009. FPR is the general partner of the limited liability company and acts as investment manager to the remaining Funds and may be deemed to indirectly beneficially own securities owned by the Funds. Andrew Raab and Bob Peck are the managing directors and managing members of FPR and may be deemed indirectly beneficially own securities owned by FPR and the Funds.
