accordance with the authority granted by shareholders at the Company's Annual General Meeting on 14 April 2016.  
These shares have been purchased as part of the \$300 million buy-back programme, the purpose for which is to reduce

The Company intends to hold these shares in Treasury.

Following the purchase of these shares, the Company holds 29,420,608 of its shares in Treasury. The Company's issued share capital, with one voting right per share consists of 884,180,565 Ordinary Shares of US20¢ each (excluding treasury shares). This is the figure which should be used by shareholders as the denominator when determining whether they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.

These purchases were made by J.P. Morgan Securities plc on behalf of the Company and a full breakdown of the individual trades is attached to this announcement.
