REPORTS ON OPERATIONS FOR THE  
FISCAL YEAR AND THREE MONTHS ENDED JULY 31, 2008

J. W. Mays, Inc. today reported its financial results for the twelve and three months ended July 31, 2008.

Revenues for the twelve months ended July 31, 2008 were \$14,646,049, compared to revenues of \$18,158,702 in the comparable 2007 twelve-month period, while revenues for the current three months were \$3,944,624, compared to revenues of \$7,975,153 in the comparable 2007 three months.

For the fiscal year ended July 31, 2008, the Company reported a net loss of (\$75,641), or (\$.04) per share, compared with net income of \$2,055,939, or \$1.02 per share, in the comparable 2007 fiscal year.

In the three months ended July 31, 2008, the Company reported net income of \$138,380, or \$.07 per share, compared with net income for the previous year's comparable three months of \$2,224,169, or \$1.10 per share.
