(the "Issuer") purchased by certain private investment funds and managed accounts advised by Nokomis Capital

(collectively, the "Nokomis Accounts"). Pursuant to Rule 16a-1, both Nokomis Capital and Mr. Hendrickson disclaim such beneficial ownership.

- (2) The purchase price represents a weighted average of the purchase price for multiple transactions on the same trading day. The range of purchase prices was \$5.20 to \$5.35. The Reporting Persons will provide upon request by the Commission staff, the Issuer, or a security holder of the Issuer, full information regarding the number of shares purchased at each separate price.

- (3) Nokomis Capital holds indirectly 4,193,894 shares of Common Stock of the Issuer through the Nokomis Accounts, for which Nokomis Capital is the Investment Manager. Brett Hendrickson reports the Common Stock held indirectly by Nokomis Capital because, as the manager of Nokomis Capital at the time of purchase, he controlled the disposition and voting of the securities.
