Fred Toney, the Chairman of the issuer's Board of Directors, is the managing member of MMR, and Mr. Toney also holds, directly and indirectly, limited partnership interests in MedCap Partners. Each of MMR and Mr. Toney expressly disclaims beneficial ownership in the securities reported on this Form 4, except to the extent of their respective pecuniary interests therein.
- The disposition of shares of the issuer's common stock reported on this Form 4 was made by the Offshore Fund as in-kind distributions to certain withdrawing limited partners.
