Mumbai, June 12, 2014: The Tata Motors Group global wholesales in May 2014, including Jaguar Land Rover, were 77,575 nos. Cumulative wholesales for the fiscal were 152,601 nos.

Global wholesales of all commercial vehicles - Tata, Tata Daewoo and the Tata Hispano Carrocera range -- were 29,161 nos. Cumulative commercial vehicles wholesales for the fiscal were 56,215 nos.

Global wholesales of all passenger vehicles in May 2014 were 48,414 nos. Cumulative passenger vehicles wholesales for the fiscal were 96,386 nos.
