This Amendment No. 4 to the Third Party Tender Offer Statement on Schedule TO amends and supplements the Third Party Tender Offer Statement on Schedule TO originally filed with the Securities Exchange Commission on August 11, 2006 (as amended by Amendment No. 1 filed on August 11, 2006, Amendment No. 2 filed on August 28, 2006 and Amendment No. 3 filed on August 30, 2006) by CCHC, LLC, a Delaware limited liability company (CCHC), CCH II, LLC, a Delaware limited liability company (CCH II), and CCH II Capital Corp., a Delaware corporation (CCH II Capital) and together with CCHC and CCH II, the Offerors , that relates to an offer to pay up to \$187,987,500 in cash, 45,000,000 shares of Charter Communications, Inc. (Charter) Class A Common Stock, par value \$0.001 (the Class A Common Stock) and \$146,250,000 principal amount of the 10.25% Senior Notes due 2010 issued by CCH II and CCH II Capital (the CCH II Notes), to holders of up to \$450,000,000 of Charter s \$862,500,000 principal amount outstanding 5.875% Convertible Senior Notes due 2009 (the Convertible Notes) who elect to exchange their Convertible Notes upon the terms and subject to the conditions set forth in the Exchange Offer Prospectus dated August 28, 2006 (as the same may be amended or supplemented from time to time, the Exchange Offer Prospectus), and the accompanying Letter of Transmittal (the Letter of Transmittal), which are part of the Registration Statement on Form S-4, as amended, dated August 28, 2006 (SEC File No. 333-136508 the Registration Statement) filed by Charter Communications, Inc., CCH II and CCH II Capital and are incorporated by reference herein.
