### Statement to Employees

On July 20, 2011, Nalco Holding Company (“Nalco”) issued the following statement regarding the proposed merger of Nalco and Ecolab Inc. to employees of Nalco:

## Do's and Don'ts During the Transition Period

### General Protocols and Guidelines

Both Nalco and Ecolab must continue to act as separate and independent companies until close.

Where we compete today, we must continue to compete until after closing.

Nalco and Ecolab employees may not speak to customers or prospects together.

Nalco and Ecolab employees may not discuss competitive plans, contract negotiations, or bid for business together prior to close.

Nalco and Ecolab may not assign people to work at the other company until after close.

Employees from one company may not direct or attempt to influence the actions of the other company's employees until after closing.

Nalco and Ecolab may not exchange confidential, sensitive information such as prices, discounts, or other terms offered to customers.

Nalco and Ecolab cannot begin account planning for the new entity.

Nalco and Ecolab cannot begin marketing planning (pricing, competitive positioning, etc.).

### Do

Continue to put safety first.

Reinforce the approved talking points when discussing the transaction with current or potential customers.

Use this news as an opportunity to check in with customers and convey support and enthusiasm for this transaction.

Ensure customers know that it is business-as-usual while we proceed toward closing in the fourth quarter of 2011.

Reassure customers that there will be no changes in service levels and product offerings and that the people they are accustomed to working with will continue working with them.

Participate in authorized integration and organizational planning activities to the extent you are asked, and adhere to the specific guidelines you receive regarding the appropriate scope of such activities.

Channel any authorized communications with Ecolab through the designated channels and points of contact.

Seek legal counsel from Nalco's Legal Department before acting to the extent you have questions about what steps can and cannot be taken or what information can and cannot be shared.

Ask the Nalco Legal Department to review any information or communication before it is disseminated broadly even if only distributed internally.

Don't

Speculate about organizational changes.

Speculate about the status of any Nalco or Ecolab line of business, plant, research center or other facility.

Denigrate competitors. We win and keep business on the merits of the value we deliver. We respect all our competitors.

Get distracted. The most important thing to do in the balance of 2011 is to keep our customers delighted with their relationship with Nalco so that we can earn the opportunity to expand our relationship with them in the future.
